Agreement

Article of Agreement made this 08.08.2023 day between Warden, MMM Hall of Residence, IIT Kharagpur (First Party) and Mr. Ashok Mourya, son of Lt. Ram Hasak Mourya, residing at BR Nagar, Purigate, Kharagpur (Town), Dist.: Paschim Medinipur, PIN No.721306 hereinafter referred to as the (second Party).

The contract shall be valid for one year initially to run Stationary Shop. Based on satisfactory behavior/performance with the boarders, the contract could be renewed further for one year by the Warden of MMM Hall of Residence.

NOW THESE PRESENTS WITNESS AND THE PARTIES hereto agree subject to the general terms and conditions regulated by the Institute as follows:

GENERAL TERMS AND CONDITIONS OF CONTRACT FOR RUNNING STATIONARY SHOP IN THE

Pt. Madan Mohan Malaviya HALL OF RESIDENCE, IIT KHARAGPUR.

1. The contract is valid only for the period from 08.08.2023 to 07.08.2024.
2. That the contract may be extended subject to satisfactory performance/behavior.
3. That the contractor must have a valid trade license for operating the shop.
4. That the contractor will pay a monthly license fees of Rs. 850/- (Rupees Eight hundred fifty only) per month for the Stationery shop space of 78 sq. ft. to the hall in advance on or before 5 days of every month. The Warden reserves the right to revise the license fees.
5. That the Stationary shop timing will be from 10 AM to 10 PM.
6. That the contractor will pay monthly electricity charges as per bill provided by Institute.
7. That failure to pay monthly license fee for consecutive two months will make the contractor defaulter and the contractor will be liable to be terminated.
8. That the contractor shall have to deposit a sum of Rs. 5,000/- (Rupees five thousand only) as security deposit with the hall, which will remain with the Warden till the tenure of the contract.
9. The Shop will transact with the boarders of the Hall.
10. That the contractor will maintain the Stationary Shop and its surroundings clean and in hygienic condition.
11. That the contractor may be allowed to keep a refrigerator of less than 200 Ltrs. Capacity.
12. That the TV and music system will not be allowed in the Stationary shop.
13. That the contractor shall not keep or serve any alcoholic item and tobacco products in the Stationary shop.
14. That the contractor under no circumstances will be allowed to give sub-contract of the Shop to other person or party.
15. That the contractor will submit name, photograph, permanent address and medical certificate in respect of the workers engaged by him in the Stationary shop.
16. That contractor shall not be allowed to engage any worker(s) of less than 14 years.
17. That any dispute arising out of the contract will be referred to the Chairman, HMC as arbitrator whose decision will be the final.
18. The contractor will maintain a complaint/suggestion box in the Stationary shop counter during the working hours.

19. The contractor shall not be allowed to make any addition and alteration of stationary shop of the hall without permission from the competent authority.
20. The shop cannot remain closed on any day without prior permission of Warden. Prior permission should be taken before reopening the shop.
21. That a fine up to Rs. 5000/- may be imposed or the contract may be terminated for violation of any of the clauses mentioned above.
22. HMC with the consent of Warden will have the full right to review the performance of the contractor, and may recommend for the termination of contract by giving a 30 days notice.
23. We, the parties to this agreement hereby bind ourselves to abide by the above terms and conditions.
