Dear Sir/ Madam,

This is in continuation of our trail mail regarding updation of PAN & Aadhaar for the associated PRANs under NPS. In this regard, please find enclosed '**PAN & Aadhaar Updation Form**' under NPS which needs to be disseminated among underlying Subscribers. The Form is also being made available on CRA website (www.npscra.nsdl.co.in).

On receipt of duly filled-up Form from the Subscribers, you are requested to update the PAN & Aadhaar details (alongwith Consent for Aadhaar) in the CRA system (www.cra-nsdl.com). The physical Forms are to be retained by the Nodal Office for record purpose.

In addition, a facility to seed Aadhaar directly in the CRA system is available to the Subscribers using their login credentials. The steps for the same are given below:

1. The Subscriber is required to log in to CRA website (www.cra-nsdl.com) using login credentials.
2. The Subscriber is required to click on Tab 'Update Details' and select 'Update Address Details' option.
3. The Subscriber is then required to click on 'Add/Update Aadhaar Number' and enter 'Aadhaar Number' & generate OTP.
4. The Subscriber is required to enter OTP received on mobile registered with UIDAI.
5. On verifying OTP, Aadhaar will be linked to PRAN.

Government Subscribers are required to get the above request authorised by their respective Nodal Office.

Subject: Circular pertaining to Amendments made under the PMLA Rules, 2017 - Making Aadhaar and PAN mandatory

Dear Sir/ Madam,

This has reference to the Circular (File No. PFRDA/17/08/11/0021/2017-SUP-SG) on the captioned subject issued by PFRDA on September 5, 2017 and received by CRA on October 6, 2017. A copy of the Circular and Amendments made under Prevention of Money-Laundering (Maintenance of Records) Second Amendment Rules, 2017 - Making Aadhaar and PAN mandatory is enclosed for your reference.

As informed in the Circular, based on the notification dated June 1, 2017, issued by the Dept. of Revenue, Ministry of Finance, bearing No. GSR 538 (E) being the Prevention of Money Laundering (Maintenance of Records) Second Amendment Rules, 2017, both Aadhaar and PAN have been made mandatory for existing and new accounts to be opened under NPS. Accordingly all existing and new Subscribers under NPS are required to submit their Aadhaar and PAN in the CRA System on or before December 31, 2017.

In view of the above, kindly note that,

· Subscribers can seed their Aadhaar to their PRAN by logging into the CRA System. The option is available under **Menu <> Update Details; Sub-menu <>**


Update Aadhaar/ Address Details.

· Subscribers can update their PAN by submitting Form S2 (Subscriber Details Change) to their associated Nodal Office (PAO/ CDDO). Nodal Office can carry out necessary changes in the CRA system.

You are requested to disseminate the above information to your underlying PAOs/ CDDOs at the earliest so as to enable the underlying Subscribers to update their Aadhaar and PAN in the CRA System on or before December 31, 2017.
