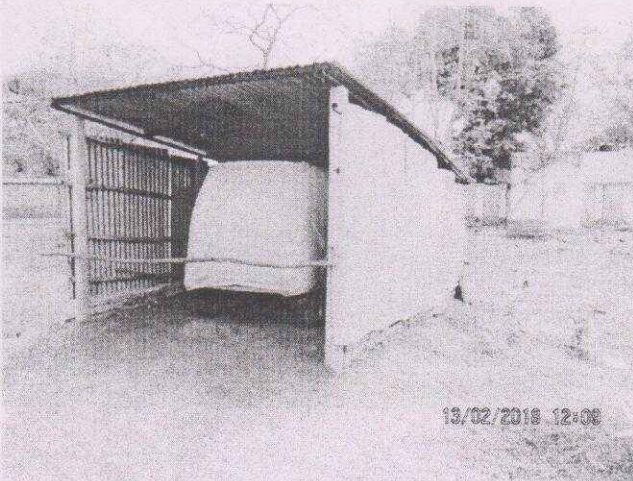
UNAUTHORIZED STRUCTURE- RESIDENTIAL AREA
